Purpose of this Document

The Gauteng Film Commission (GFC) wishes to appoint suitably qualified and experienced Service Providers to supply and maintain Microsoft 365/Office and Exchange Online licences for a contractual period of twenty-four (24) months

The following documents and requirements need to accompany the quotations - Tax clearance certificate accompanied by a pin for further verification.

- Certified BBBEE certificate, SBD 4 and 6.1
- All prospective bidders must be registered on the Central Supplier Database (CSD)

Evaluation Process

PRICE AND BBBEE POINTS

The 80/20 preferential point system as per the [Treasury Framework Act of 2000](#) will be applied, where 80 points will be allocated for price and 20 points for B-BBEE Status

1. Contract Period and Microsoft Subscription Terms

The GFC contract period shall be twenty-four (24) months. Where Microsoft makes an applicable CSP/New Commerce Experience licence available on a twelve-month subscription term, the successful bidder shall provision the subscription for the first twelve months and renew it for the subsequent twelve months. The service provider shall remain contractually responsible for maintaining uninterrupted licensing for the full 24-month contract period.

Bidders must not interpret the 24-month contract period as requiring a single 24-month Microsoft subscription where Microsoft does not make such a subscription term available for the proposed SKU.

2. Licence Requirements

The appointed service provider/s will be expected to deliver on the following specification:

3. Minimum Requirements

- The bidder must be authorized to transact the proposed Microsoft licences through the Microsoft CSP channel, directly or through an authorized distribution arrangement.
- The bidder must provide the exact Microsoft product/SKU and applicable subscription term for each licence item.
- The bidder must commit to supply and maintain the required licences for the full 24-month GFC contract period.
- Where annual Microsoft subscription terms apply, the bidder must manage the Year 2 renewal without interruption to GFC services.
- The bidder must provide support for licence provisioning, assignment, renewal and CSP administration for the duration of the contract.
- Any exclusions, assumptions or dependencies affecting Year 2 pricing must be clearly disclosed in the quotation.

The 24-month total will be used for price comparison, subject to the evaluation methodology and applicable SCM requirements. Bidders must not leave Year 2 pricing blank. If Year 2 is subject to an adjustment mechanism, the bidder must state the basis and maximum/controlled mechanism clearly.

5. Year 2 Price Adjustments

Where the bidder cannot provide a fixed Year 2 Microsoft licence price because the underlying Microsoft subscription renews annually, the bidder must clearly state the proposed adjustment methodology. Any adjustment must relate to demonstrable changes in the applicable Microsoft/CSP licence cost and must be supported by documentary evidence at renewal. The bidder's own margin, administration fee or service fee must be separately disclosed and may not be increased unless expressly provided for in the contract.

6. Evaluation and Responsiveness

Quotations must address the full 24-month contractual requirement. A quotation covering only 12 months, without a contractual commitment and pricing methodology for the second year, may be regarded as non-responsive.

7. Submission

Completed quotations and supporting documentation must be submitted in accordance with the GFC submission instructions by the closing date and time stated above. Late submissions may not be considered.

8. Important Note

This RFQ replaces the previously issued Microsoft licensing RFQ. Quotations submitted under the cancelled RFQ will not automatically carry over to this procurement. A new submission is required.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

NB: BEFORE COMPLETING THIS FORM, TENDERERS MUST STUDY THE GENERAL CONDITIONS, DEFINITIONS AND DIRECTIVES APPLICABLE IN RESPECT OF THE TENDER AND PREFERENTIAL PROCUREMENT REGULATIONS, 2022

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and

1.2 **To be completed by the organ of state**

(delete whichever is not applicable for this tender).

- a) The applicable preference point system for this tender is the **80/20** preference point system.
- b) The **80/20 preference point system** will be applicable in this tender. The lowest/highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 **To be completed by the organ of state:**

The maximum points for this tender are allocated as follows:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

 - iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
 - (a) disqualify the person from the tendering process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.

- 3.6 I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
